Terms and Conditions

Salt River Project (SRP) is offering this rebate program to help customers install qualifying energy-efficient equipment. Please make sure you read and understand the terms and conditions below.

Qualifying Customers

To qualify for a rebate, customers must purchase and install qualifying measures in a residence served by an SRP residential electric price plan. Eligible price plans include the following: Basic Plan (E-23), Time-of-Use Plan (E-26), M-Power (E-24) and EZ-3 Plan (E-20).

Qualifying Equipment

Rebates are available for clothes washers and dishwashers that meet or exceed the efficiency requirements specified in this application. Information about qualifying equipment can be found at www.srpnet.com/powerwise. All equipment must be new and purchased between May 1 and Sept. 30, 2009, prior to submitting an application. All rebate applications must be received by SRP no later than Oct. 31, 2009.

Which Appliances Qualify?

Qualifying appliances must meet or exceed the following standards outlined by the Consortium for Energy Efficiency (CEE):

Appliance	CEE Level	Super-Efficient Appliance Standards	Rebate
Clothes Washer	CEE Tier 1	MEF of 1.8 or greater and WF of 7.5 or less	\$ 50
	CEE Tier 2 or higher	MEF of 2.0 or greater and WF of 6.0 or less	\$75
Dishwasher	CEE Tier 2	EF of 0.68 or greater and max. annual energy use of 325 kilowatt-hours	\$ 20

Clothes Washer Ratings:

- **MEF:** The Modified Energy Factor (MEF) measures energy consumption of the total laundry cycle, including drying. The higher the number, the greater the energy efficiency.
- **WF:** The Water Factor (WF) represents the number of gallons of water needed for each cubic foot of laundry. The lower the number, the less water use.

Dishwasher Rating:

- **EF:** The Energy Factor (EF) reflects the number of cycles per kilowatt-hour (kWh). The higher the number, the more efficient the dishwasher.

Rebates

One rebate check will be issued per approved application to the person listed on the application. Customers will be subject to a maximum of one rebate per appliance type. Equipment qualifying for rebates under the SRP Appliance Rebate program is not eligible for purchase and installation rebates or credits under any other SRP programs. Program procedures, requirements and rebate levels are subject to change or cancellation at any time. Customers must abide by the program rules, eligibility requirements, and rebate levels in effect at the date of the equipment purchase.

Application Details

Applications will be accepted and reviewed on a first-come, first-served basis while program funding is available. Applications must include all requested information. Failure to provide this information may result in the delay or denial of the rebate.

SRP reserves the right to conduct random inspections to verify information provided in this application. If selected for inspection, the rebate will be withheld pending outcome of the inspection. If the equipment is found to be in compliance with the program requirements, the rebate will be paid. If the equipment is not in compliance, the customer will be notified.
