PROGRAM TERMS AND CONDITIONS

To participate in the SRP Energy-Efficient Pools Program, the following conditions apply:

- The homeowner must be a current SRP residential electric customer.
- The pool pump must be installed in SRP service territory.
- The pool pump must be purchased from a participating retail outlet or installer.
- The pool pump must be a qualifying, new variable-speed unit. Rebuilt motors do not qualify.
- The pool pump must be installed on a single-family residential, in-ground swimming pool.
- The pool pump must be calibrated after installation by an SRP-qualified pool professional.
- There is a limit of one pool pump rebate per address.
- The homeowner must abide by the rules and rebate levels in effect at the date the pool pump was installed. For current program requirements and program effective dates, go to savewithsrp.com or call the SRP Energy-Efficient Pools Program line at (602) 236-9606.
- Pumps installed prior to May 15, 2011, do not qualify for this program.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice.
- Failure to provide any of the required information, including signatures, will result in the denial of the pool pump rebate.

The rebate application and calibration report must be submitted within six months of the pump purchase date (as per the invoice) to be eligible for payment.

REBATE ASSIGNMENT AUTHORIZATION

I agree that neither SRP nor its officers, directors, employees, agents, representatives, affiliates, successors and assigns will be responsible or liable for any claims arising out of or resulting from the pool pump's and contracting company's performance.

I hereby authorize SRP to transfer any rebate that I may be entitled to under the Energy-Efficient Pools Program directly to the third party named below, from which I purchased the pool pump. The third party will discount the price of the pool pump by the amount of the rebate that is being transferred. I understand that I will receive no additional rebates or incentives from SRP related to this purchase. I certify that all information provided herein is accurate to the best of my knowledge, that SRP may verify the accuracy of all information and that all installations are subject to random inspections by SRP or an authorized third party. By signing below, the pool contracting company certifies that it has reviewed the customer's SRP bill to confirm that this installation is eligible to receive a rebate at the address shown above.
