INSTRUCTIONS

The following information must be provided when a modification is made to an existing Residential Solar Electric Application and Agreement (“Agreement”). In order for SRP to process this Residential Solar Electric Application and Agreement Addendum (“Addendum”), the following information must be provided:

1. A completed Addendum, including all necessary signatures.
2. Revised three-line electrical diagrams if modifications were made to the system. Drawings must be identified as revisions with an updated date stamp.
3. A revised site plan if modifications were made to the site information. Drawings must be identified as revisions with an updated date stamp.
4. A quote on company letterhead that includes the customer’s name and address, system description, estimated installation date, and cost if the modification resulted in a change to the quote for the system.
