Requests for an Early Voting Ballot will be accepted beginning Jan. 4, 2026, and must be received in the Corporate Secretary's Office by 5 p.m. on Friday, March 27, 2026. You will also be mailed an Official Early Voting Ballot for any runoff elections. Check the Permanent Early Voting List box to receive ballots for qualifying future elections.
