Reserve Fund	The District has covenanted in the Resolution to maintain the Debt Reserve Account at the Debt Reserve Requirement. As of July 31, 2025, the balance in the Debt Reserve Account was approximately \$81 million, which exceeded the Debt Reserve Requirement. Upon the issuance of the 2025 Series C Bonds, the amounts on deposit in the Debt Reserve Account will continue to exceed the Debt Reserve Requirement.

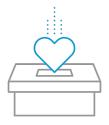

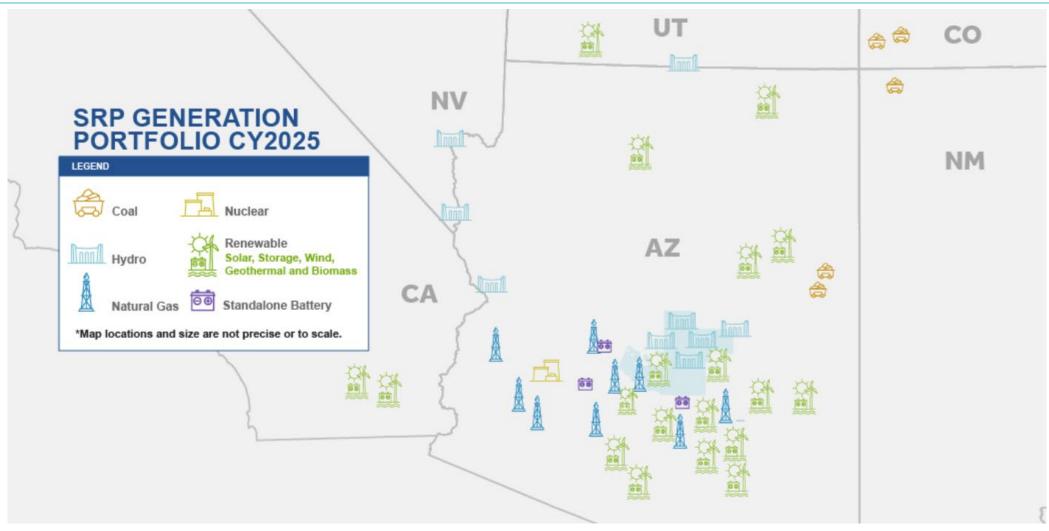

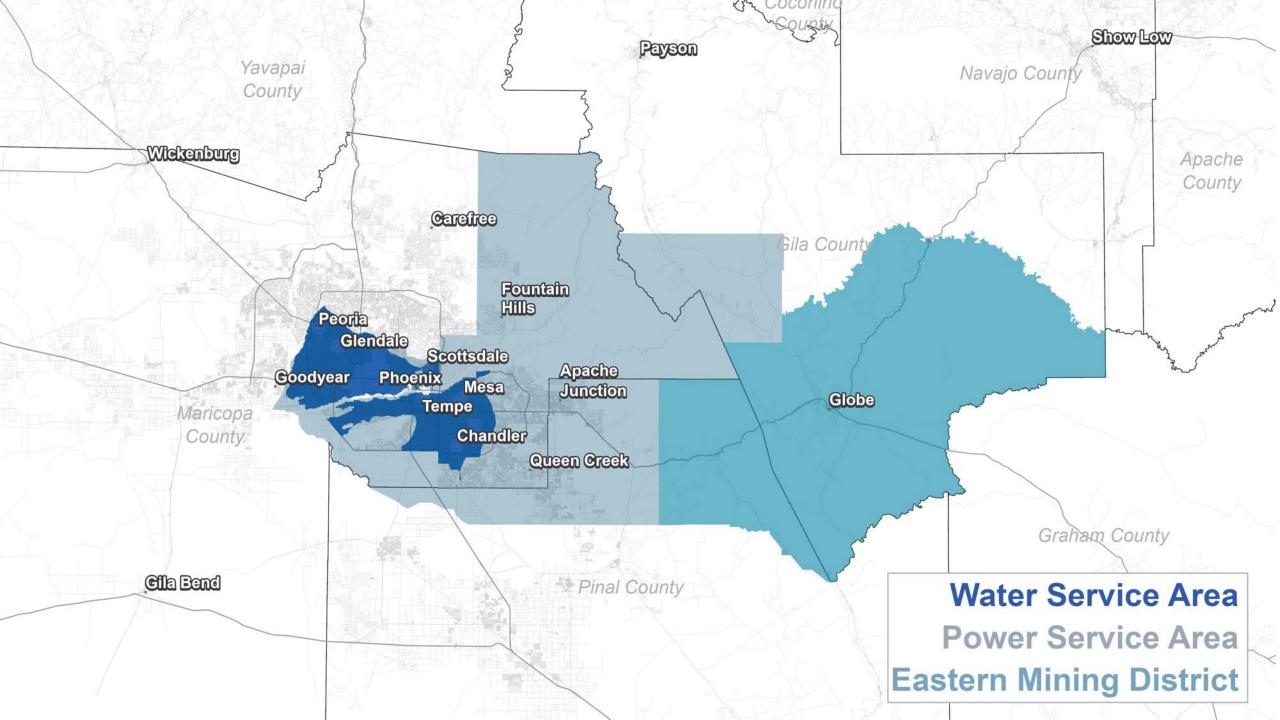

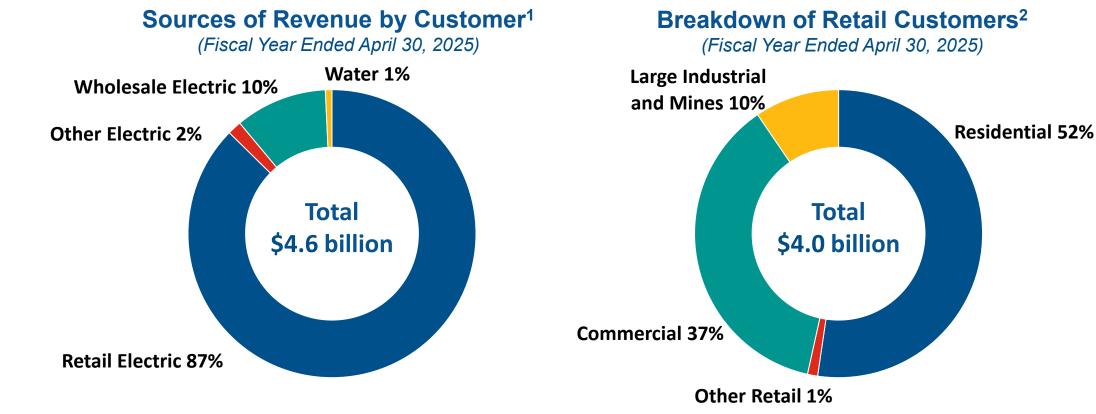

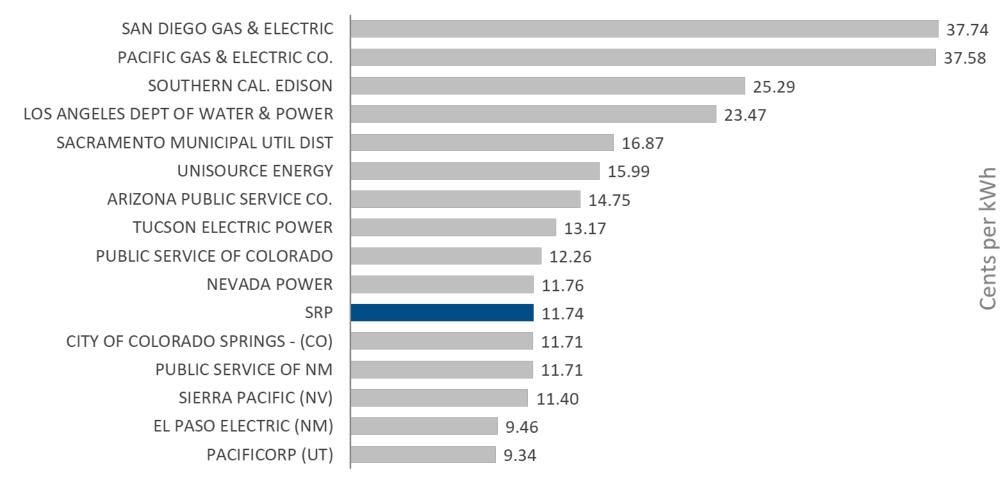

2035 Sustainability Goals

Updated March 2024

The progressive actions taken today will help ensure SRP can deliver on the 2035 Sustainability Goals and meet water and power needs of today's customers and future generations.

SRP's goals, originally approved in 2019, are evaluated every five years to make sure they continue to meet the evolving needs of the Valley.

In March 2024, SRP established new, more ambitious targets, including a goal to reach net zero carbon emissions by 2050.

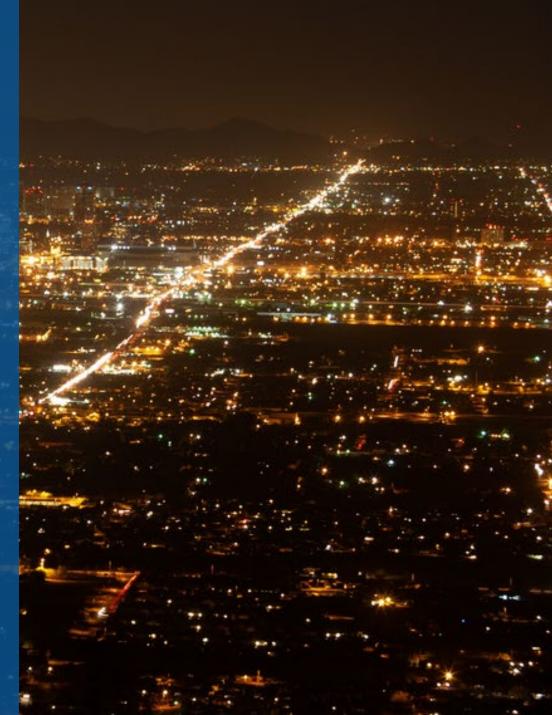

Strong Economic Growth

- The District serves approximately half of the population in the Phoenix Metropolitan Statistical Area (Phoenix-Mesa-Chandler MSA in U.S. Census Data)
- Governmental and economic center of Arizona, home to the largest percentage of Arizona's residents, businesses, and income
- Growing at a steady pace with addition of ~943,700 people from July 2012 through July 2024, a compound annual growth rate of ~1.7%
- From July 2019 to July 2024, employment had a net gain of 13.6% or 288,900 jobs
- Sales forecasted to grow at an annual rate of 9.4% from fiscal year 2026-2031

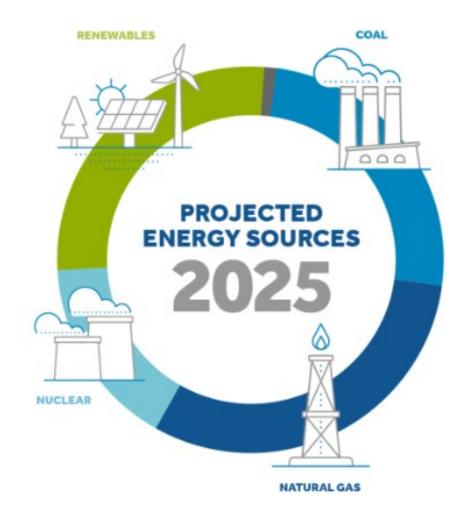

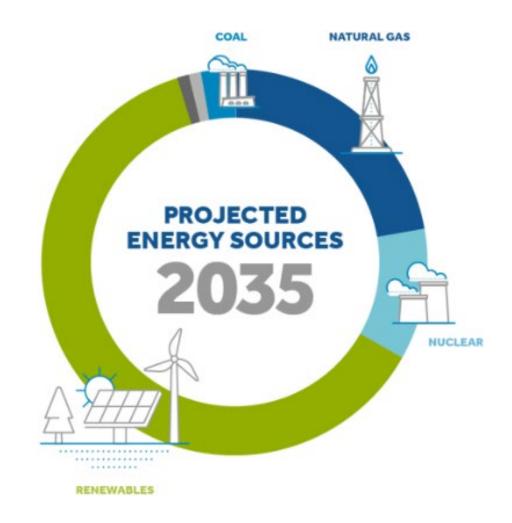

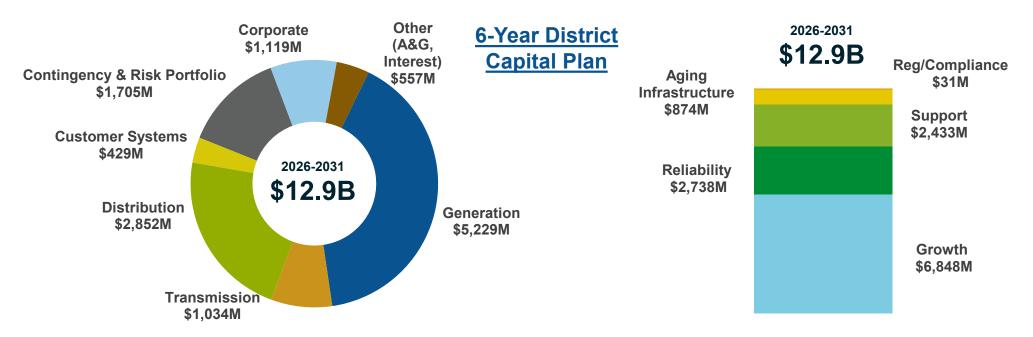

Projected Capital Spending & Borrowing Plans

- ❖ The Capital Improvement Program for fiscal years 2026 through 2031 totals approximately \$12.9 billion
 - Approximately \$12.4 billion is for construction (including contingencies)
 - \$5.2 billion for generation, including plant betterments and future generation facilities
 - \$2.9 billion for electrical distribution system, for future growth and replacing aging underground cable
 - \$1.0 billion for transmission, including pole asset management, line additions, and station upgrades
 - The District anticipates funding approximately 45% from Revenue Bonds, other forms of indebtedness and third-party contributions; the remainder is anticipated to be funded by internally generated funds

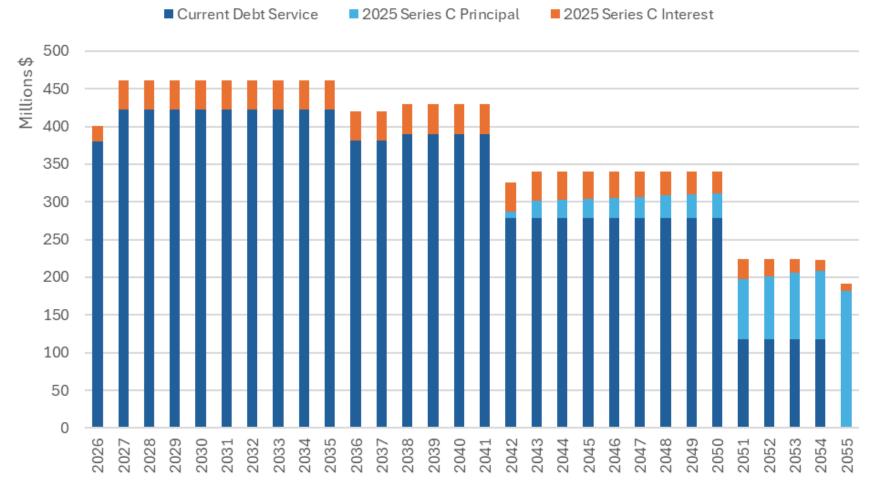
