SUPPLEMENTAL AGREEMENT SRP COMMERCIAL SOLAR ELECTRIC PROGRAM

[NON-INCENTIVE]

This Supplemental Agreement supplements the SRP Commercial Solar Electric Program Requirements ("Solar Agreement") and sets out the terms of SRP's participation with ("SRP Customer") to purchase and provide to SRP
Customer the output of a photovoltaic solar facility (the "Solar Facility") to be installed and operated on SRP Customer's premises by("Solar Provider").
Solar Provider
Solar Provider agrees to sell the output of the Solar Facility to SRP at the rate specified in Exhibit A. The terms of the sale will be per a separate power purchase agreement between SRP and Solar Provider (the "Power Purchase and Sale Agreement"). The output of the Solar Facility will be measured by a meter to be installed by SRP. Solar Provider authorizes SRP to release generation data related to the Solar Facility to SRP Customer, upon SRP Customer's request.
SRP Billing
SRP will bill SRP Customer for the entire output of the Solar Facility at the rate specified in Exhibit A, on SRP Customer's regular monthly bill. SRP Customer will have the benefit of SRP's standard buy back rider or net metering rider, as applicable, in the event that SRP Customer is unable to use the entire output of the Solar Facility at any time. SRP's billing will be subject to taxes and other charges as applied generally to SRP Customer's account
SRP's Right to Enforce SSA Agreement
SRP Customer and Solar Provider have entered into a contract for the installation and maintenance of the Solar Facility dated (the "SSA Agreement"). To the extent that the SSA Agreement is inconsistent with the terms of this Supplement, the terms of this Supplement shall govern. SRP Customer and Solar Provider agree that SRP shall have the right, but not the obligation, to enforce, with Customer's consent, any of the terms of the SSA Agreement on behalf of SRP Customer, and shall have the right to inspect the Solar Facility at any time. SRP shall not be subject to any term of the SSA Agreement.
Rules and Regulations

SRP's Rules and Regulations shall apply to this Supplement. This Supplement shall supplement the Solar Agreement, and is subject to the Distribution Interconnection Agreement, and the Solar Electric Installation Certification, signed by SRP Customer and the Solar Provider. This Supplement shall terminate upon the earlier of the (1) termination of the Power Purchase and Sale Agreement, (2) termination of the SSA Agreement, or (3) termination or disconnection of SRP Customer's account with SRP.
