Using innovative lighting technologies, SRP offers ways to improve operations, productivity and security, all while optimizing your energy usage and costs, through the Lighting Solutions component of SRP Standard Business Solutions.

Our program offers rebates for:

- LED fixtures and lamps (retrofits require ENERGY STAR® or DesignLights Consortium certification)
- Qualified lighting controls

Thanks to SRP, you can benefit from these and other lighting technologies and receive cash rebates of \$0.25–\$0.35 per reduced watt (W) of installed demand reduction for interior LED lighting, \$0.15 per watt of installed demand reduction for exterior LED lighting, and up to \$0.40 per watt controlled for qualifying lighting controls. Rebates are available for retrofit and new construction projects.

WHY LIGHTING?

Lighting can account for as much as 40% of your total electric bill. Inefficient, outdated lighting systems may also produce more heat, which puts an additional load on your air-conditioning system.

Upgrading your lighting can be a cost-effective way to:

- Reduce your energy use
- Lower your monthly electric bill
- Improve your lighting quality
- Reduce your carbon footprint

State-of-the-art interior retail lighting promotes and accents products and displays. Ergonomically efficient indoor lighting can improve occupant productivity, comfort and morale.

UPGRADES THAT CAN SAVE YOU MONEY

Here are some examples of the possible savings:

- Replace high-intensity discharge (HID) lighting or linear fluorescent lighting with LEDs and you can reduce lighting energy costs by up to 50%.
- Replace a fluorescent exit sign with an LED sign, and you can save \$10–\$15 per year. Replacing an incandescent sign can save more than \$20.

BENEFITS

1. Energy-efficient LED lamps emit less heat and can lower your air-conditioning costs.
2. You may reduce your lighting costs by an average of 35% while improving the quality of light.
3. The longer equipment life of LED lamps and fixtures reduces maintenance and disposal costs.
4. Reduced flicker can increase employee and customer comfort.
5. Upgrading lighting equipment also helps to address spaces that are over-lit. And because LEDs are highly controllable, new LED lighting systems can take advantage of “daylight harvesting,” automatically adjusting light levels in spaces with windows in order to provide just the right amount of light. Both of these benefits provide additional energy-saving opportunities.
6. Newer lighting may improve the appearance of your facilities and products, with better and more consistent color rendering.
7. Energy-efficient lighting helps reduce your facility’s carbon footprint.

HOW TO PARTICIPATE

Follow these simple steps to apply for a rebate. All applicable forms are available at [savewithsrpbiz.com](https://www.savewithsrpbiz.com).

Retrofits

1. Complete and submit the lighting application to obtain preapproval from SRP for your retrofit lighting project.
2. Purchase and install the eligible measure(s) after approval has been received from SRP.
3. Resubmit the lighting application with installed retrofit measures and dated invoice(s) or purchase order(s) for final approval.

New construction

1. Complete and submit a rebate reservation request (optional).
2. Purchase and install the qualifying equipment.
3. Complete and submit a lighting application and dated invoice(s) or purchase order(s) for approval.

Customers are subject to a maximum rebate of \$450,000 from May 1 through April 30 for all SRP programs, with separate program area caps of \$300,000 for Energy Efficiency programs, \$300,000 for Business EV programs, and \$100,000 for Electric Technology programs. Program or technology-based limits may also be applicable, based on program terms and conditions. SRP reserves the right to determine at their sole discretion the program year to which a rebate is attributed.

Rebate funds are limited and available on a first-come, first-served basis. Check the availability of program funds on the website or contact the program administrator at **(602) 236-3054**.
