NEW BUILDING LIGHTING EQUIPMENT ELIGIBILITY

- To be eligible, equipment must be purchased between May 1, 2024, and April 30, 2025, and must be received no later than Oct. 31, 2025 (subject to rebate availability). Rebate eligibility is determined based on the eligibility rules in place on the purchase date.
- Equipment must be new and installed in a manner that meets or exceeds code regulations.
- E-39 Mogul based and/or HID replacement lamps are not eligible for rebate.
- Retrofit LED fixtures and lamps (except exit signs) must be UL-rated and on one of the following qualified product listings at the time of application approval: ENERGY STAR[®] or DesignLights[™] Consortium.
- In order to be eligible for the rebate, the lighting project must produce a 10% or greater installed demand reduction from ASHRAE 90.1-2016 lighting power density specifications by building type, as calculated by the Standard Business Solutions Lighting Application. Additional information on rebate calculations can be found in the SBS Program Manual.
