Pursuant to A.R.S. § 38-431.02, notice is hereby given to the members of the general public, the parties and the Arizona Power Plant and Transmission Line Siting Committee ("Committee"), that the Committee will hold a public meeting/hearing on the above application that is open to the public at Mesa Convention Center, 263 North Center Street, Mesa, Arizona 85201, commencing on Thursday, September 6, 2018 at 1:00 p.m., and will continue on Friday, September 7, 2018, beginning at 9:30 a.m. The hearing will recess until Monday, September 10, 2018 beginning at 10:00 a.m. and will continue each weekday on September 11, 2018 through September 14, 2018, as necessary, at the same location beginning at 9:30 a.m. each day, unless a tour is taken. If a tour is taken, it will begin on Tuesday, September 11, 2018, at approximately 9:00 a.m. or an alternative date and time set by the Chairman of the Committee ("Chairman"). Public comment will be taken in a special evening session on Thursday, September 6, 2018 at 6:00 p.m. and may be taken at the beginning of each hearing day

1 or at other times during the hearing at times designated by the Chairman. Unless later
2 ordered by the Chairman, the hearing will adjourn at approximately 5:00 p.m. each day.

3 Additional days for the hearing may be set, and the hearing may conclude earlier
4 or later than anticipated, depending upon the number of parties that intervene, the
5 amount of testimony presented, the amount of public comment, and the time needed for
6 deliberations by the Committee. As a part of the public meeting/hearing, members of
7 the Committee will discuss the potential value of a tour, and, at the discretion of the
8 Chairman, may tour the location of the proposed power plants and transmission lines for
9 the project as set forth above.

10 At the public meeting/hearing, the Committee may consider, discuss, deliberate
11 and/or vote on the matters on the agenda. Items on the agenda may be taken in a
12 different order than listed as conditions require:

1 7. If it is decided a tour would be valuable, the Committee will meet at the
2 hearing site. The members of the Committee will tour the project. Members
3 of the public may follow the Committee's tour. No testimony or discussion
4 with or between Committee members about the application or matters relating
5 to the application will take place, except on the record before a court reporter
6 at the designated stops. The Chairman will make any procedural decisions
7 concerning stops at different points of interest;

9 8. Discussion of proposed findings of fact, conclusions of law, the certificate of
10 environmental compatibility and conditions to the certificate of
11 environmental compatibility;

12 9. Vote and decision concerning findings of fact, conclusions of law, the
13 certificate of environmental compatibility and conditions to the certificate of
14 environmental compatibility;


